





BALLOT LTD. - TERMS AND CONDITIONS

DELIVERY:

Goods will be shipped by an appropriate carrier within 4 working days of acceptance of the order by Ballot Ltd.

RESTRICTIONS:

Ballot Ltd. reserve the right to refuse or restrict any order or application.

DELAY IN SUPPLY:

Ballot Ltd can accept no liability for loss or damage arising from any delay in supplying goods.

BILLING:

All fees and expenses will be paid for in advance by the customer (Unless expressly agreed by Ballot Ltd. in writing). A receipt for payment will be issued by BALLOT Ltd. within 21 working days of acceptance of the goods by the customer.

REJECTED GOODS:

Goods may be returned at the customer's expense to Ballot Ltd. within 14 days of delivery. Full reimbursement of payment will be made by Ballot Ltd. subject to payment of any shipping charges and to the condition of returned goods.

SHORTAGES AND DISCREPANCIES:

Shortages, discrepancies and damage to goods must be notified to Ballot Ltd. in writing within seven days of delivery date.

CUSTOMER CONTACT:

The client will nominate a person responsible for the acceptance of goods.

IMPRINT:

Ballot Ltd. reserve the right to affix a discreet sign on their products carrying the legend Ballot Ltd. and contact details.

CURRENCY:

All charges and payments are to be made in pounds sterling.

VAT:

All charges are subject to an addition for Value Added Tax at the rate appropriate at the date of the account.

PRICES:

Ballot Ltd. reserve the the right to alter prices without prior notice. Ballot Ltd. shall be entitled to charge for any additional costs caused by the buyer's failure to accept the ordered goods when they are due for delivery.

OWNERSHIP OF GOODS:

All goods delivered by Ballot Ltd. to the buyer's premises or order shall remain the property of Ballot Ltd. until payment in full has been received by Ballot Ltd.

LIABILITY:

Unless expressly stated by us goods are not sold as conforming to any British Standard specification and Ballot Ltd. shall only be liable for loss or damage caused by factors reasonably within our control.

AGREEMENT:

This proposal, terms and conditions represent the entire agreement between the customer and Ballot Ltd. and will supersede all prior negotiations, representations or agreements, written or verbal, and may be amended only by Ballot Ltd. expressly in writing.
